

Grants

Pharmacosmos Therapeutics is committed to partnering with medical, scientific, patient, and civic organizations to support their programs and activities, such as health education and scientific research. This support takes many forms, including educational funding requests, charitable contributions, scholarships and fellowships, and independent research.

Independent Medical Education (IME)

Pharmacosmos Therapeutics supports grants for independent medical education in an effort to further the advance of medicine and health care by improving the knowledge of the medical community. Independent Medical Education is defined as education that is evidence-based, fair-balanced, unbiased, planned and implemented independent of industry influence, and free of bias. Pharmacosmos Therapeutics is actively seeking applications for IME activities for healthcare professionals, teams, patients, payers and systems designed to:

- Improve knowledge, enhance skills, and support behavior change
- Close clinical and practice gaps
- Improve the quality and delivery of patient care
- Enable patients to take an active role in their healthcare

Entities eligible to apply for support include:

- Hospitals, academic medical centers, and medical schools
- Medical associations and societies
- Medical education companies
- Publishers of medical and scientific publications

Grant requests must identify unmet educational needs of a target audience and demonstrate how the program will address the unmet educational needs, and encourage the improvement of medicine and healthcare.

Scholarships or Fellowships

Scholarships and fellowships are grants to independent professional organizations, independent charitable organizations, or other eligible institutions, where the funds are used to support advanced study by clinical and research professionals at an accredited university or teaching institution. The recipients of all scholarships and fellowships must be determined by the relevant training institution or medical association, with no involvement from Pharmacosmos Therapeutics. The scholarship/fellowship must be open to all qualified candidates in a reasonably defined geographic or therapeutic area, and the application and selection process must be clearly defined and widely published. Grants must be given directly to the academic or training institution and not to an individual HCP or individual candidate.

How to Apply

Requests can be made directly via email to Grants@Pharmacosmos.us and must include the following to be considered complete:

- Grant request form (please email Grants@Pharmacosmos.us or ask your MSL for a copy)
- W9, plus 501(c)(3) paperwork if appropriate.
- Request letter signed on requestor's letterhead.
- Grant proposal with agenda/ program details.
- Full budget information for the activity, including portion of budget directly being requested from Pharmacosmos Therapeutics.

Process

Once the full grant request package is received, it is reviewed at the next Grants Review Committee meeting, held on a monthly basis. Once a decision is reached, you will be notified via email.
